## EXTERNAL COMMUNICATION

To: B3's Market Participants – BM&FBOVESPA Segment, Cetip UTVM Segment and Cetip UFIN Segment – Vendors, DMA Providers and ISVs

Re: **Deactivation of FTP Server and BM&FBOVESPA and Cetip Portals, and Discontinuation of BD/BDI in PDF Format.**

For several months B3 has been working to facilitate clients' access to information about its markets.

The initiatives resulting from this effort include UP2DATA, a service that centralizes end-of-day market information and assures its availability in a simple, efficient and timely manner, as detailed at [www.b3.com.br/up2data](http://www.b3.com.br/up2data).

The following will therefore be deactivated on **November 30, 2018**:

- the FTP server ([ftp.bmf.com.br](http://ftp.bmf.com.br)), whose data files will be made available thereafter by the service UP2DATA;
- the portals [bmfbovespa.com.br](http://bmfbovespa.com.br) and [cetip.com.br](http://cetip.com.br), whose content will be integrated into the portal [www.b3.com.br/en\\_us/](http://www.b3.com.br/en_us/) from July 30, 2018.

Also on **November 30, 2018**, B3 will stop publishing the Daily Bulletin (BD) and the Daily Information Bulletin (BDI) in PDF format, since the information required by the regulator will be available from the integrated portal [www.b3.com.br/en\\_us/](http://www.b3.com.br/en_us/).

It is important to note that implementation of the integrated site will require the replacement of all hyperlinks to [bmfbovespa.com.br](http://bmfbovespa.com.br) and [cetip.com.br](http://cetip.com.br), impacting routines used by the market to collect data from these channels.

In light of these changes, participants are called upon to make the necessary alterations to their processes to ensure that the information currently available from the FTP server and the above portals can be accessed directly through UP2DATA as of December 1, 2018.

We emphasize that data made available on Market Data channels (UMDF PUMA 2.0 and UMDF PUMA Conflated), MTA and Secure Transport will not be affected by the changes described above.
